## Agreed Procedures for Accessing and Using Tapestry Online Learning Journeys



Tapestry is an online journal recording all the learning and fun of children's early years' education. Tapestry allows staff to capture children's learning using iPods and iPads whilst in Reception.

We use this information to inform our assessment of the children against the Early Years Foundation Stage Framework. Continuing on from previous successful years, we would like you to begin their journal during the summer holiday so we can build up a picture of your child's interests and activities they enjoy with you at home.

This agreement will need to be signed before we can activate your accounts. We have provided you with a 'how to guide' with an overview of Tapestry and how to access your child's page.

As a parent/carer I/we will:

- Not publish any of my child's observations, photographs or videos on any social media site e.g. Facebook,
   Twitter etc.
- Only access Tapestry with my own login and password which I will keep secret.
- Speak to a member of staff if I experience any difficulties accessing my child's learning journey at the earliest opportunity.
- Not post inappropriate and/or offensive materials, including photographs or videos.
- Be aware that use of Tapestry falls under the Social Media and E-Safety policy which are available for me to read on the school website.

## Tapestry Set-up

A parental email is required to set up the account, and by providing the e-mail address parents will have access to Tapestry

Please write legibly otherwise the account will not be set up.

Different parental email accounts are required for each parent/carer.

When you receive the email, from Tapestry, confirming your parental account has been made you need to ensure your password is strong. The password must be at least 12 characters long, have at least one uppercase letter, one number and one symbol. It must not be too easy to guess. Tapestry will check the password against a list of common passwords when it is submitted. Current UK government advice is that passwords should be based on three random words; be different for each service you use; and never be: any family member's name, a pet's name, place of birth, favourite holiday or anything relating to a favourite sports team.
